2 (On record - 12:03 p.m.)

3 CHAIRMAN TILLERY: Okay, this is a continued --  
4 this is Craig Tillery, this is a continuation of our previous  
5 meeting. At the meeting we have Frank Rue representing the  
6 Department of Fish and Game; Ginny Fay representing the  
7 Department of Environmental Conservation; Steve Pennoyer with  
8 NOAA; Jim Wolfe with the Forest Service; and Deborah Williams  
9 with the Department of Interior; and myself with the Department  
10 of Law.

11 We don't have any minutes, we don't even actually, at  
12 this point, have a written agenda. It is my understanding that  
13 the agenda for this meeting is primarily an executive session.  
14 to discuss habitat acquisition issues. Is there any other item  
15 that needs to be brought up today besides that?

16 MS. McCAMMON: That's it, Mr. Chairman.

17 CHAIRMAN TILLERY: Okay. Given that, I would  
18 entertain a motion to go into executive session.

19 MS. D. WILLIAMS: Mr. Chairman, we do have Greg  
20 Petrich on and I don't know if we -- if he would like to say a  
21 few words but I think, if he does, we could entertain that now.

22 CHAIRMAN TILLERY: We could. My understanding  
23 was he wasn't really -- that we're not going to be taking any  
24 action today or -- and that my understanding was that he wasn't  
25 going to be speaking, but, Greg, did you want to say something

1 for a couple of minutes. I know you.....

2 MR. SWIDERSKI: We also have a limited amount  
3 of time.

4 CHAIRMAN TILLERY: I note that there is a  
5 letter from Greg to Molly McCammon, which I hope everyone has a  
6 copy of.

7 MS. D. WILLIAMS: I do not.

8 CHAIRMAN TILLERY: Can we fax.....

9 MR. MYERS: I believe we did try to fax it to  
10 you within the last half an hour. I'm not sure what fax number  
11 we had for you. Do you have a number that we should try to fax  
12 it to, Deborah?

13 MS. McCAMMON: Can you just summarize it for  
14 us, Eric?

15 MS. D. WILLIAMS: Some could just.....

16 MR. SWIDERSKI: It's a short letter, you could  
17 read it.

18 MS. D. WILLIAMS: Yeah, right.

19 CHAIRMAN TILLERY: Greg, can you just -- do  
20 you have any comments that you'd like to make orally in  
21 addition to your letter?

22 MR. PETRICH: No. Well, I think that the  
23 primary one is that there's this real heightened level of  
24 concern on the environmental side that the components of this  
25 negotiation can get complex and we're working up against a time

1 deadline with this appraisal expiration, in a lot of people's  
2 minds, so that's really of concern. You know, we're trying to  
3 think of ways and proposals to accommodate, you know, land  
4 owners and retain our best areas but we realize it's a pretty  
5 difficult situation. And, you know, we just want to see the  
6 best effort that you can put forth here in a short period of  
7 time to try and get something palatable to the land owners, you  
8 know.

9 And you, of course, have some, I'm sure, executive  
10 session ideas that, you know, may be information that we don't  
11 have and so may I just say from our standpoint that it's a very  
12 critical acquisition to us and as much flexibility as we can  
13 show, you know, is appreciated to make it work.

14 CHAIRMAN TILLERY: Okay. Thank you, Greg. Are  
15 there any questions from Council members or comments?

16 (No audible responses)

17 CHAIRMAN TILLERY: Okay. I -- excuse me, wait  
18 a second.

19 (Whispered conversation)

20 CHAIRMAN TILLERY: We have just received word  
21 that Tim Mahoney and Howard Valley would like to be added in.  
22 How do we do that?

23 MS. YOCKEY: I'm going to call (indiscernible -  
24 away from microphone).....

25 MR. ROTH: Maybe you can call the 1-800 number

2           CHAIRMAN TILLERY: Yeah, we're going to try to  
3 do that. Is it the desire of the Council to perhaps -- the two  
4 choices, as I see it, would be go into executive session and  
5 have them on at the end or to, I guess, stand down for about  
6 five minutes while we try to add them on and see if they wish  
7 to make any comments. What's the sense of the Council?

8           MS. D. WILLIAMS: Even though I am time  
9 pressed, I would like to hear them before we go into executive  
10 session.

11           CHAIRMAN TILLERY: Okay, then let us try to add  
12 them on. Just while we're doing that, what is people's time  
13 pressures today?

14           MS. D. WILLIAMS: I am supposed to check out of  
15 my condo at noon, so that's, you know, 53 minutes.

16           CHAIRMAN TILLERY: Okay. Is there anybody else  
17 that's under an immediate time constraint?

18           MR. RUE: This is Frank Rue, I got Rob Bosworth  
19 with me, I have to catch an airplane, so I'll be leaving here  
20 at the latest at 12:45.

21           CHAIRMAN TILLERY: Okay.

22           MR. RUE: Rob can be here for a little longer.

23           CHAIRMAN TILLERY: Okay, great.

24           MR. RUE: Be listening in.

25           MR. SWIDERSKI: Should we read this letter

1 while we're stopped?

2 CHAIRMAN TILLERY: Yeah, I guess for purposes  
3 of those people who do not have a copy of Greg's letter, I will  
4 just summarize it for you.

5 Greg thanks the -- it's a letter to Ms. McCammon, he  
6 thanks the staff for working with him and taking time to meet  
7 and explain the developments. He notes that the Alaska Rain  
8 Forest Campaign is a coalition with longstanding interests in  
9 protecting high value forests and fish and wildlife habitats.  
10 And that safeguarding key northern lands on Afognak Island is  
11 AJV-1 and AJV-3 have been and are continuing to be the highest  
12 priorities for the campaign. And in their view any habitat  
13 proposal should seek to retain the largest possible amount of  
14 uncut forests in those two key areas.

15 He goes on to note that proposal have been made to  
16 expand the acreage of the overall buyout, they do not wish to  
17 dismiss ideas which could lead to a successful conclusion.

18 ATT OPERATOR: ATT operator adding Howard  
19 Valley, go ahead, please.

20 CHAIRMAN TILLERY: Okay.

21 MR. VALLEY: Thanks. Somehow I got cut off.

22 CHAIRMAN TILLERY: Okay. And we're still  
23 trying to add in Tim Mahoney, I take it?

24 MR. SWIDERSKI: Yeah, I believe so.  
25 (Phone ring)

1 CHAIRMAN TILLERY: Is that?

2 MS. D. WILLIAMS: Tim?

3 CHAIRMAN TILLERY: Is Tim Mahoney on?

4 (No audible response)

5 CHAIRMAN TILLERY: Okay. And just, I think, in  
6 conclusion in Greg's letter he notes that at least one recent  
7 proposal, in their view, lacks sufficient information, AJV-4 to  
8 evaluate it from a public interest perspective. He ask that  
9 the Council.....

10 ATT OPERATOR: This is the ATT operator again  
11 adding Tim Mahoney on line. Go ahead.

12 CHAIRMAN TILLERY: Okay, thank you. And he  
13 concludes by asking that the Council make available adequate  
14 staff and resources to work on the negotiations.

15 Tim Mahoney and Howard Valley have joined us. This is  
16 the meeting of the Exxon Valdez Trustee Council, the only item  
17 on the agenda is an executive session on habitat acquisition.  
18 Greg Petrich just made a brief, two or three minute, comment  
19 with respect to the AJV proposed acquisition and we would like  
20 to know if either of you would like to make a comment on that  
21 or other habitat acquisition matters?

22 MR. MAHONEY: If either Howard or Tim?

23 CHAIRMAN TILLERY: That's correct.

24 MR. MAHONEY: Well, this is Tim. AJV has a  
25 series of proposals before the Trustees. We believe we have

1 dealt with the Trustees fairly and patiently and without  
2 posturing. I think there is some belief on the part of AJV  
3 that while we think we understand the limitation and priorities  
4 that the Trustees operate under, there have been times when the  
5 AJV partners think that, perhaps, the Trustees do not  
6 understand that AJV differs from perhaps some of the other  
7 sellers in having their own crews, data, their own appraisal  
8 analysis that they've been working with throughout this decade  
9 and when AJV analyzes any kind of a proposal they do so  
10 comparing it to their own numbers. And the numbers are --  
11 depending on the unit, they are about five to 15 percent higher  
12 than the appraised numbers that the Trustees are using.

13 This has led us to think that if the Trustees cannot  
14 adjust their timber numbers that the way to make an agreement  
15 work is to put land in the -- in combination with timbered  
16 land, non-commercial timbered land, in an agreeable package  
17 where both sides could agree on a bottom line number, each side  
18 might look at the component parts of that differently, but we  
19 believe that there is a possibility for a solution there.

20 I think, from AJV's standpoint, we don't think we're  
21 getting through very well because of the responses from the  
22 Trustees have tended to be very timber heavy, very unmixed,  
23 between land and timber. And because the Trustees are  
24 unwilling to go above the value numbers that came up in the  
25 Cascade appraisal, that leaves AJV short and AJV can't agree to

1 any of those proposals. The last proposal that came from the  
2 Trustees would have been for AJV, it would have essentially  
3 been meeting its timber needs and throwing in the land for  
4 free. And AJV, in that instance, could not agree to sell. But  
5 we have put forward more proposals because we think that there  
6 must be a way to do this.

7 CHAIRMAN TILLERY: Okay, thank you, Tim.  
8 Mr. Valley, did you have any comment that you would like to  
9 make?

10 MR. VALLEY: No, not at this time, thank you.

11 CHAIRMAN TILLERY: Okay. Are there Council  
12 members that have questions or comments with regard to  
13 Mr. Mahoney's comments?

14 MS. D. WILLIAMS: I do, Mr. Chairman.

15 CHAIRMAN TILLERY: Okay, Ms. Williams.

16 MS. D. WILLIAMS: This is for either. In  
17 looking at your latest proposal and particularly at Alternative  
18 II where the possibility would be to increase about a quarter  
19 of the timber from Unit 3(A), have you had the opportunity to  
20 discuss that with ADF&G or anyone else to determine what  
21 quarter that would be and how it would be configured; has there  
22 been any discussions along that line?

23 MR. MAHONEY: No discussions. This is Tim  
24 Mahoney. When we configured that in trying to put together a  
25 proposal. We looked at the priority listing of subunits that

1 Mike Wiedmer and the other biologists had worked out last fall.  
2 They ranked their subunits in order of importance and we worked  
3 our way up from least important up, taking away the -- I think  
4 there was something like nine subunits that we had been looking  
5 at previously. So to take about a quarter of the timber away  
6 we took out the lower most five subunits and left in the larger  
7 four primary subunits which are all contiguous.

8 MS. D. WILLIAMS: Okay. All right. And then  
9 with respect to the trade out for timber of equal value in Seal  
10 Bay State Park; can you just describe that a little more?

11 MR. MAHONEY: Well, we've -- as we've said, we  
12 need a -- from our standpoint we need a mix of land and timber  
13 and without that mix our differences in timber value are too  
14 great to make an agreement possible. So the negotiators for  
15 the Trustees had indicated that they did not want to include  
16 any lands in the Paramanof Peninsula, Unit 4, and they only  
17 wanted to look at the other units. That led us to say that  
18 that was possible but only if we shrank the amount of timber in  
19 the deal.

20 We've always said that we would be open for a timber  
21 for timber trade, so when we put this on the table, we took the  
22 approximately \$5,000,000 worth of timber out of 3(A) and said  
23 we would hold it for a couple of years during which time we  
24 would enter into, if you chose, a separate negotiation on the  
25 potential trade outs. I think some of that timber, maybe a

1 quarter of it, could be found just along the road corridor that  
2 would have to be built to connect up to the logging operation  
3 that's tentatively agreed to in Unit 3(A). The rest would have  
4 to be located within the Seal Bay Park and because this land  
5 was once part of the Afognak Joint Venture, AJV has crews maps  
6 and has knowledge of the timber values there, so we know what  
7 is possible, but we've not engaged in any serious discussions  
8 as to whether it's -- there's a likely timber swap there or  
9 not.

10 MS. D. WILLIAMS: Mr. Chairman, that's all the  
11 questions I have.

12 CHAIRMAN TILLERY: Okay. Are there other  
13 Council members that have any questions or comments?

14 MS. McCAMMON: Mr. Chairman, this is Molly  
15 McCammon.

16 CHAIRMAN TILLERY: Ms. McCammon.

17 MS. McCAMMON: Tim, could you explain AJV's  
18 perspective and clarify for the Council that this ratio between  
19 the timbered lands and the non-timbered lands is not just an  
20 economic issue of trying to make up the difference in the  
21 timber values, but it's also from the perspective of AJV that  
22 they're not willing to sell just high valued timbered lands.  
23 Can you reflect that?

24 MR. MAHONEY: Okay. Yes, that would be good,  
25 thanks for asking. When AJV began this process, what now, four

1 or five years ago with the Trustees, timber prices were higher,  
2 the -- but even so AJV believed that it was not in its  
3 interest, economically or as far as the partner corporations  
4 felt was in their interests, to sell only the trees and be left  
5 with a number of non-timbered acres which had less development  
6 potential. Instead, AJV embraced the idea of selling something  
7 that was approximately proportional in terms of land -- of  
8 non-commercial timbered land and commercial timbered land, and  
9 tried to leave its remaining lands in place. AJV, unlike some  
10 of the other sellers, is not planning to go out of the timber  
11 business, it would remain in the timber business but in perhaps  
12 a smaller capacity than before or for fewer years out into the  
13 future. So they did not want to high grade. I think overall  
14 commercial timber makes up about a quarter of all of the AJV  
15 lands. The proportion that is in all of the proposals that AJV  
16 puts forward to the Trustees is higher than that but the  
17 Trustees proposals to AJV have been overwhelmingly timbered  
18 lands.

19 So even when prices were very high and timber would  
20 make a great return, AJV was not interested in an unbalanced  
21 approach. With timber prices low, AJV would not sell its most  
22 valuable assets in kind of an overwhelming manner. We sort of  
23 look at it the way you might look at a stock that is currently  
24 devalued. The idea is to sell high and buy low. When the  
25 stock is devalued you would not sell the preponderance of your

1 assets at that ratio -- at that rate. So the two ideas, the  
2 idea that AJV has always had that there needs to be a balance  
3 of timber and non-timber and the thought that's very recent  
4 that perhaps the non-timbered lands could help balance out our  
5 differences in value kind of came together, but only this  
6 winter.

7 CHAIRMAN TILLERY: Okay. Ms. McCammon, does  
8 that answer.....

9 MS. McCAMMON: Yes, thank you.

10 CHAIRMAN TILLERY: Did you have any other  
11 things that you thought the Council should hear from  
12 Mr. Mahoney?

13 MS. McCAMMON: No.

14 CHAIRMAN TILLERY: Okay. Are there other  
15 Council members with any questions or comments?

16 (No audible responses)

17 CHAIRMAN TILLERY: Okay, is there anyone else  
18 on the teleconference or here in Anchorage that would like to  
19 make a comment, since we are into public comment apparently?

20 (No audible responses)

21 MS. D. WILLIAMS: Mr. Chairman, I move we go  
22 into executive session to discuss habitat acquisition.

23 CHAIRMAN TILLERY: Is there a second?

24 MR. RUE: Second.

25 CHAIRMAN TILLERY: All in favor say aye.

1 IN UNISON: Aye.

2 CHAIRMAN TILLERY: Opposed.

3 (No opposing responses)

4 CHAIRMAN TILLERY: Okay, this meeting will  
5 adjourn and go into executive session. Logistically, how is  
6 that going to happen.

7 MS. YOCKEY: I'm going to have to call the  
8 operator.

9 CHAIRMAN TILLERY: Okay, so does everybody hang  
10 up? Is that the way we do this?

11 MS. YOCKEY: Yes.

12 CHAIRMAN TILLERY: Okay, everybody should hang  
13 up. In terms of how long the executive session is going to  
14 take, I know we had set aside until about another hour.  
15 Deborah is going to have to leave. Deborah, do you have a --  
16 is Barry on?

17 MR. ROTH: Yes.

18 MS. D. WILLIAMS: Mr. Chairman, I'll ask if --  
19 I'll have my husband ask if we can have a late check-out.

20 CHAIRMAN TILLERY: Okay, all right.

21 MS. McCAMMON: Mr. Chairman, could we just have  
22 the two (sic) public member maybe just hang up and -- do we all  
23 have to.....

24 MS. D. WILLIAMS: That would be a lot easier.

25 MS. McCAMMON: It would be quicker. I trust

1 them that they would do that.

2 MR. MAHONEY: We're happy to accommodate you on  
3 this side.

4 MR. PETRICH: No problem.

5 CHAIRMAN TILLERY: There's three public  
6 members, just looking to see who's here, -- okay, yeah, so I  
7 guess -- I don't know how long this executive session is going  
8 to last, but I would suggest anywhere from a half an hour to  
9 hour, probably leaning more towards the hour. When we come  
10 back, undoubtedly, we will simply go back into public session  
11 for purposes of closing it out. I don't anticipate any kind of  
12 action. Do the public members wish to come back on the line at  
13 that time?

14 MR. PETRICH: I'd be interested in -- yes, if  
15 there's additional information.

16 CHAIRMAN TILLERY: Okay. If we're going to  
17 come back simply for the purposes of adjourning, do you want to  
18 be back on?

19 MR. PETRICH: No, just if there's any  
20 significant development.

21 CHAIRMAN TILLERY: Okay. And how about for  
22 Mr. Mahoney and Mr. Valley?

23 MR. MAHONEY: No, we don't have -- we will  
24 participate as you wish.

25 CHAIRMAN TILLERY: Okay.

1 MR. VALLEY: I guess to know that the meeting  
2 was over might be beneficial for us here.

3 CHAIRMAN TILLERY: Okay, what we'll do is, I  
4 think, is we'll go into executive session, if we're going to do  
5 anything when we come out, other than simply adjourn and report  
6 on the fact that we held an executive session, we will call  
7 these numbers and try to bring you back in, otherwise we'll  
8 simply call you and let you know that the meeting is over.

9 MR. PETRICH: Okay.

10 CHAIRMAN TILLERY: If that's okay for  
11 everybody. Okay, so if you three could hang up.

12 MR. PETRICH: Fine and -- this is Greg and I  
13 just really appreciate the vacationers touching base here,  
14 that's above the call of duty, so thank you.

16 CHAIRMAN TILLERY: Thank you.
