A request was made April 18, 2022, for a no-cost extension for Kenai Peninsula Aquatic Ecosystem Restoration (15-01, 16-02 and 18-01) through SFY2025. The extension was requested due to a construction delay related to right-of-way acquisition on the larger highway upgrade that the final fish passage project is a part of. The project is moving forward now, the pre-bid meeting was completed in April at the Anchorage DOT office, after which the project will go out to bid with construction of the fish passage element scheduled for either fall or 2022 or spring of 2023, depending on contractor schedule. In April, we requested an end date of end of SFY

### 1. Summary of Work Performed:

### Project A, North Fork Anchor River and Nikolaevsk Road:

This project was completed in the fall of 2021, at a cost of \$2,061,671.31.

### Project B, Two Moose Creek:

This project is part of the multi-year Sterling Highway upgrade, MP 157-169. Design and right of way acquisition is complete and the project is going through the State of Alaska bidding process currently. Construction of the new culvert is anticipated to take place in the spring of 2023, but a final decision will depend on the sequencing of the overall project agreed upon by the AKDOT and the selected contractor. The EVOS funded portion of this project is anticipated to come in at budget

### **Project C, North Fork Anchor River at the Sterling Highway:**

This project is also part of the Sterling MP 157-169 upgrade and will also replace the undersized and perched culverts at MP 157 with a bridge, where the North Fork Anchor River crosses the Sterling Highway. Construction of the new culvert is anticipated to take place in the spring of 2023, but a final decision will depend on the sequencing of the overall project agreed upon by the AKDOT and the selected contractor. No EVOS funds will be used on this project.

### Project D, Crooked Creek and Sterling Highway:

Project was completed in 2019 and came in under budget at a total cost of \$4,361,786. The remaining funds were redirected to Project A in case of cost overruns.

### Additional Project, Coal Creek at the Sterling Highway:

Coal Creek was completed in the summer of 2019 and was included with Project D for budgeting purposes.
