Thank you for the opportunity to comment on the EVOSTC's Delta Plan. Koniag was surprised to learn that the EVOSTC needed to reconsider previously approved projects due to recent decline in the value of its securities portfolio, however we are hopeful that the EVOSTC will find a way to fund these important projects. Specifically, Koniag is concerned that the \$8 million approved out of the Research Subaccount for the Alutiiq Museum & Archaeological Repository Sustainability Project may be in jeopardy and we encourage the EVOSTC to pursue a plan that will preserve this funding and allow the Alutiiq Museum's project to proceed.

Given the previous approval of \$8 million in funding to the Alutiiq Museum from the EVOSTC, there has been a flurry of activity to move the project forward. Koniag acquired the 50% ownership interest in the facility from Natives of Kodiak and, together with the Kodiak Area Native Association which owned the other 50%, donated the entire facility ownership to the Alutiiq Museum. In addition, Koniag has pledged \$1.2 million to the project. The Alutiiq Museum has proceeded with design for the renovated facility and was on the verge of beginning the construction contract RFP process when we learned that the EVOSTC funding may be jeopardy. Without the EVOSTC funding, the project simply can-not proceed and if funding is provided at a reduced amount, additional efforts to raise capital will need to be initiated, but sources will be limited as many have already pledged support.

Therefore, in reviewing the three alternatives in the 2022 Delta Plan it appears that Alternative Orange would provide the most assurance that projects would receive their full, approved funding by combining the Research and Habitat Subaccounts. Koniag supports Option A of Alternative Orange as it may provide more opportunity for the combined Subaccount funds to generate earnings and would provide clear Congressional intent and approval to combine the Research and Habitat Subaccounts.

Thank you for the opportunity to comment on the EVOSTC's Delta Plan. Kodiak Area Native Association (KANA) was surprised to learn that the EVOSTC needed to reconsider previously approved projects due to recent decline in the value of its securities portfolio, however we are hopeful that the EVOSTC will find a way to fund these important projects. Specifically, KANA is concerned that the \$8 million approved out of the Research Subaccount for the Alutiiq Museum & Archaeological Repository Sustainability Project may be in jeopardy and we encourage the EVOSTC to pursue a plan that will preserve this funding and allow the Alutiiq Museum's project to proceed.

Re: Comments regarding the EVOSTC proposed Delta Plan options.

Chugach is an Alaska Native Corporation created under the Alaska Native Claims Settlement Act (ANCSA) whose region covers all of Prince William Sound and lower Cook Inlet. The communities in our region include Valdez, Tatitlek, Chenega, Cordova/Eyak, Whittier, Seward, Port Graham and Nanwalek. The Chugach region was the area most devastated by the Exxon Valdez Oil Spill, which happened just a short distance from the village of Tatitlek.

It is unfortunate that funding mechanisms for approved projects needs to be revisited due to a number of factors, including lower expected returns of the trust due to changing market conditions. Chugach is especially concerned about the funding for the Chugach Archaeological Repository and Museum as well as our funding for regional culture camps. We encourage the council to approve a plan that will continue to allow these programs to proceed as approved at the October 2021 EVOSTC meeting. These projects are important to protect and share knowledge related to the history, heritage and traditional ecological knowledge of the indigenous people of the Chugach region. We appreciate the EVOS trustee council recognizing the importance of involvement of the Alaska Native people and communities in our region in your earlier funding decisions.

In reviewing the various options outlined in the 2022 Delta Plan, it appears that Alternative Orange would be the best option to assure that our programs would receive funding by combining the Research and Habitat subaccounts. Chugach supports Option A of Alternative Orange as it appears it would allow for greater investment earnings to the fund, which would narrow the funding gap as well as provide Congressional approval to combine the Research and Habitat subaccounts in order to best honor the intention of the EVOSTC funding decisions.

The goal should be to finish the legacy of the EVOS Trustee process by using the remaining funds to do the most good with the highest impact that serves the future needs of our children and grandchildren. The smartest and wisest use of the funds will need to set priorities and make tough decisions.
- 3. Some user groups will not be satisfied. If the decision process is not transparent, with public input, some user groups will probably sue, consuming funds, and delaying the process.
- 4. The purple alternative is the least work, most efficient administratively, and will likely produce the lease bang for the buck, as it keeps the two pots of funds separate and does not permit the combining to fund the highest priority projects.
- 5. Orange is a good choice, but it is not transparent, will not satisfy all of the different competing interests, invites law suits, and delays.
- 6. Green choice is a more transparent version of orange, allowing the limited funds to support more of the priority projects for a longer period of time, and allows for public input.

Conclusion: The green choice is probably the best choice.
