The Trustee Council is to engage the public in revisiting its previous funding decisions for fiscal year 2027 through fiscal year 2031, as described. The Science Panel and Public Advisory Committee will be asked to revisit the proposals funded and offer recommendations to the Trustee Council on how best to maximize the number of projects that can be funded. The Trustees will also work to maximize the use of the funds remaining in both the Research and Habitat Subaccounts, including through finding efficiencies that can be made, unused funds, and the degree of public participation and involvement in the decision-making process will also be an emphasis. Funding for any public engagement activities will be allocated evenly from the Research and Habitat Subaccounts. The Trustee Council authorizes Council staff to analyze administrative costs and equally distribute them, either historically or going forward, drawing from the Habitat Subaccount to minimize the funding shortfall in the Research Subaccount
