**SUBJECT:** FY2023 Investment Report Update

Please find attached the following Alaska Department of Revenue, Treasury Division monthly and summary reports for the *Exxon Valdez Oil Spill Investment Fund* for the EVOSTC Fiscal Year (FY) 2022 (February 1, 2023 – January 31, 2024) reporting period. Effective August 2022, significant changes to the target asset allocations for both the Research and Habitat subaccounts were approved by the Trustee Council. The target asset allocations for both subaccounts were switched from a mix of mostly Broad U.S. and International Equity, Core U.S. Fixed Income to Cash Equivalents and Intermediate Fixed Income to minimize risk and exposure to principal loss.

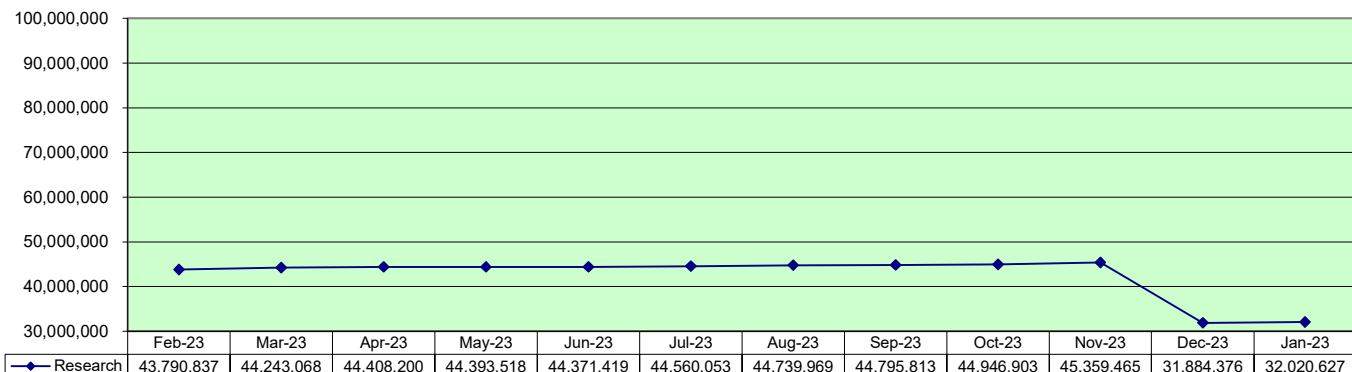

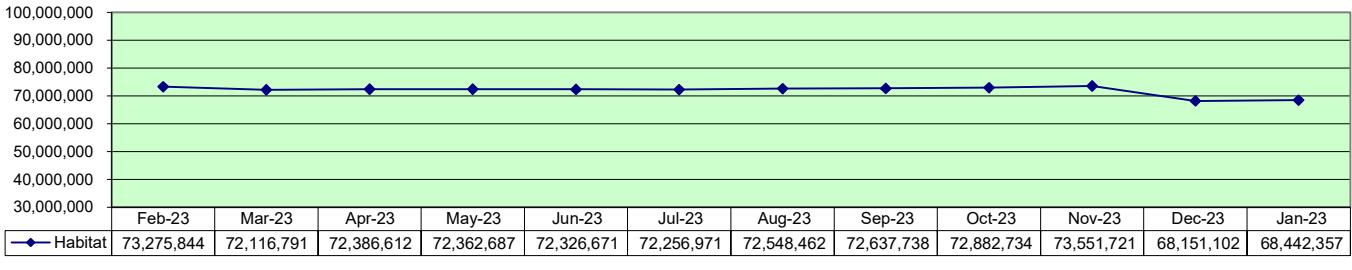

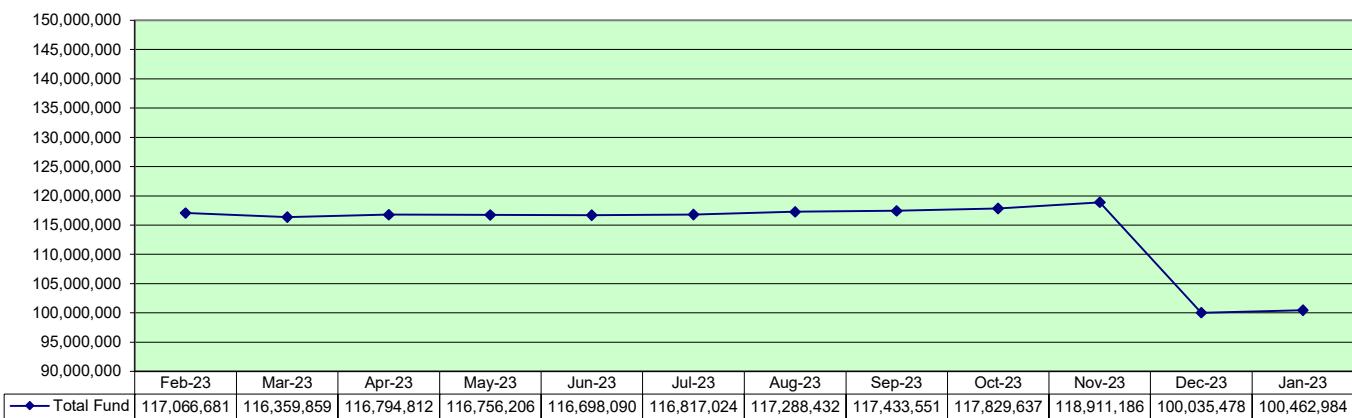
### EVOSTC FY23 Research Sub-Account Invested Assets

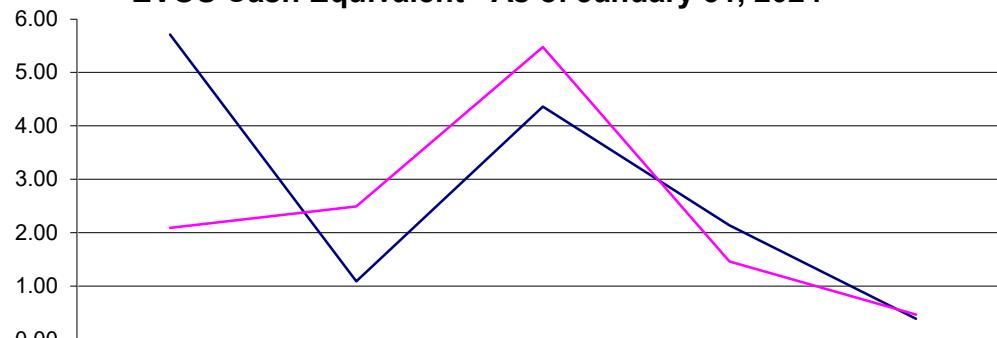

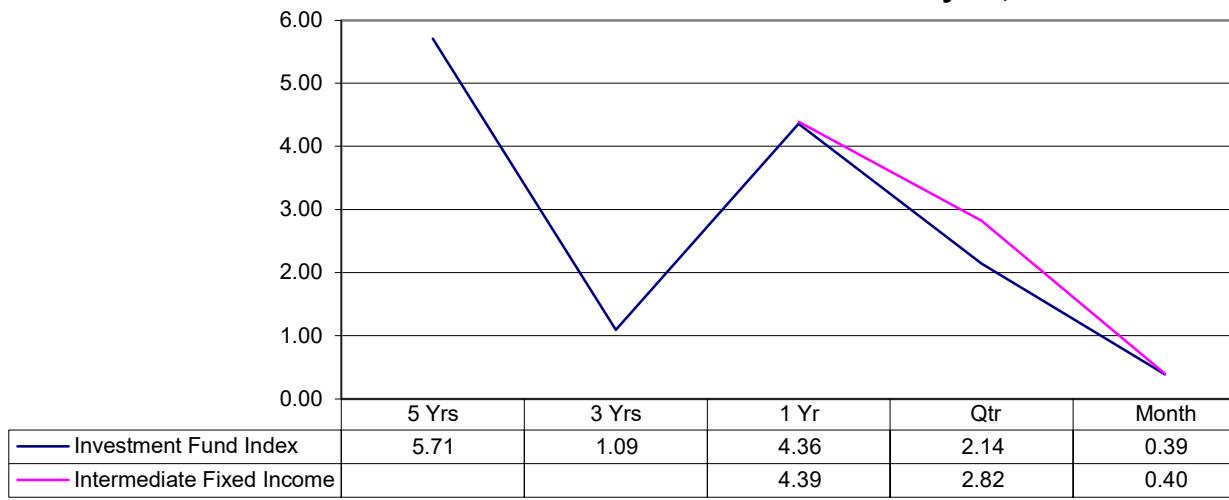

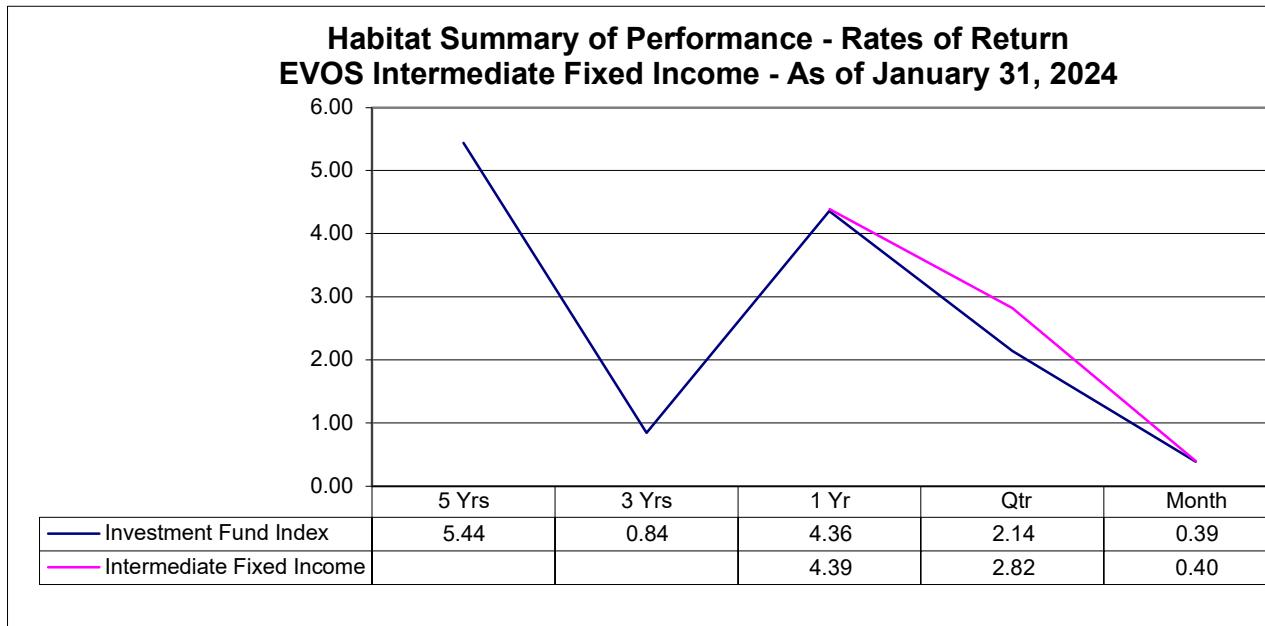
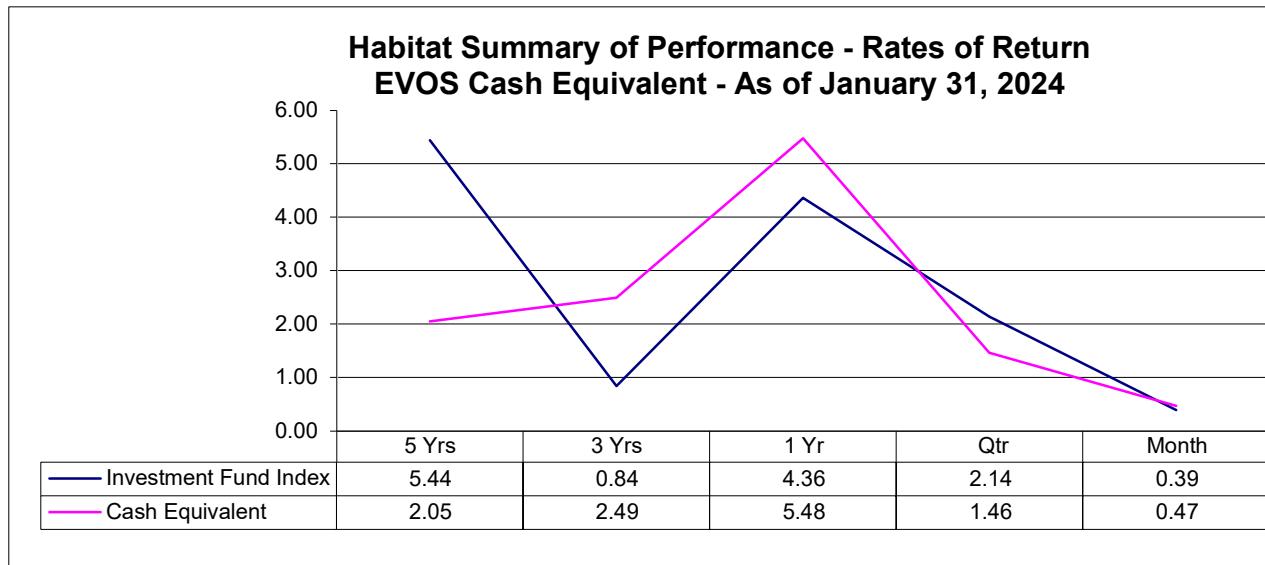


**Research Summary of Performance - Rates of Return
